The need for revising the Graduate Exit Survey, the Alumni Survey and the Employee Survey was also discussed as well as the Focus Group questions.	The evaluation plan for student outcomes will be revised to include data from the signature assignments in the courses and other assignments as appropriate. The Program Coordinators will review the courses and indicate the assignments. Course Summaries will also be used for the evaluation of student outcomes. Satisfaction Surveys as well as graduation rates, certification pass rates and employment will continue to be used for student outcome evaluation data. Individual course evaluations will also continue to be trended to identify potential
		for program improvement.  The Graduate Exit, Alumni, and Employee Surveys will be revised by the Committee to reflect the new student outcomes by fall 2012 as this is the first class that will graduate using the new Essentials of Master's Education in Nursing (2011).  The Focus Group questions will be revised and ready for spring 2013. (Focus Groups are held in spring semesters).
